The OSHA 30 Hour Construction Industry Outreach Training Course is a comprehensive safety program designed for anyone involved in the construction industry (workers and supervisors). Course includes several topics valuable to construction related work, such as Fall Protection, Excavations, Scaffolding, OSHA Inspection Procedures, and more. Upon successful completion, students will receive Course Completion Cards from OSHA for the 30 Hour Construction Industry.

## 8-Hour Fall Prevention Site Safety Training Course (SST-307)

This awareness level 8-Hour Site Safety Training is required by NYC LL196 and is a prerequisite for some construction, demolition workers, and supervisors at certain construction sites within the five boroughs of NY to obtain a Site Safety Training Cards. Trainees will become generally familiar with the terms associated with fall hazards and controls in the construction industry as they pertain top construction in New York City; will be able to recognize and avoid fall hazards and prevent fall-related incidents from occurring or causing harm; learn of roles, responsibilities, and accountabilities of various individuals on a construction site.

**4-Hour Supported Scaffold User & Refresher Course (SCA-211)**

Individuals who use a supported scaffold (regardless of height of the scaffold), including the person supervising such, shall, at a minimum, have completed a NYC DOB 4-hour training program and, every four years thereafter, retake the 4-hour training course in accordance with Chapter 33 of the NYC DOB Building Code.

**40-Hour Site Safety Training Course (SAF-102)**

The 40-hour curriculum covers the NYC Building Codes, including the requisite review of Chapter 33 ‘SAFEGUARDS DURING CONSTRUCTION OR DEMOLITION”, AS WELL AS CURRENT Federal and State regulatory standards and applicable laws to ensure compliance and safe work practices in construction.
